DECLARATION OF A PROTECTION ZONE AND SURVEILLANCE ZONE

- This declaration is made under article 31 of the Foot-and-Mouth Disease (England) Order 2006 (S.I. 2006/182) ("the Order").
- Terms defined in the Order have the same meaning in this declaration.
- The Secretary of State declares that from 11:55 a.m. on 7th August 2007:
 - the area described below in Part 1 of the Schedule and comprising the area delimited in blue on the map in Part 3 of the Schedule is a protection zone in which the measures in Parts 1 and 2 of Schedule 5 of the Order apply; and
 - the area described below in Part 2 of the Schedule and comprising the area delimited in black on the map in Part 3 of the Schedule is a surveillance zone in which the measures in Parts 1 and 3 of Schedule 5 apply.

Failure to comply with this Declaration may be an offence under section 72 or 73 of the Animal Health Act 1981.

Note - The Declarations made at 22.00 on 4th August 2007 and 13.50 on 5th August remain in effect. This Declaration supplements existing measures, extending the protection zone and surveillance zone. The protection and surveillance zones made under all Declarations are shown on the map in Part 3 of the Schedule to this Declaration (with areas added by the new zones shown with hatching).

SCHEDULE

PART 1: PROTECTION ZONE

FMD03 (Aug 7)

The protection zone comprises that part of Surrey contained within a circle of radius three kilometres, centred on grid reference SU93800 51800. The grid reference is a British National Grid Reference.

PART 2: SURVEILLANCE ZONE

The surveillance zone comprises those parts of the counties of Surrey and Hampshire contained within a circle of radius ten kilometres, centred on grid reference SU93800 51800. The grid reference is a British National Grid Reference.
